FMR Co. carries out such voting under written guidelines established by the Board of Trustees of the Funds which are the registered holders.

Fidelity Management Trust Company ("FMTC") is a trust company organized under the laws of Delaware and is a wholly-owned subsidiary of FMR Corp.
